

ORDINANCE 18-12-23(a)

AN ORDINANCE LEVYING AND ASSESSING THE TAXES OF THE LAN-OAK PARK DISTRICT,  
COOK COUNTY, ILLINOIS FOR THE 2023 TAX LEVY YEAR

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE LAN-OAK PARK DISTRICT,  
COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The sum of \$1,645,065 or so much thereof as may be authorized by law is hereby assessed and levied for the anticipated objects and purposes hereinafter specified against all taxable property within the LAN-OAK PARK DISTRICT at full, fair cash value as the same is assessed and equalized for state and county purposes, for the 2023 tax year.

Section 2: Hereafter set forth under the column "Amount levied" is the specific amount hereby levied for each object and purpose.

Section 3: Pursuant to Section 4-4 of the Park District Code (70 ILCS 1205/4-4) neither the Budget and Appropriation Ordinance of the District for the current fiscal year beginning May 1, 2023 and ending April 30, 2024 nor any other Budget and Appropriation Ordinance is intended or required to be in support of or in relation to the tax levy made in this ordinance.

Section 4: The Secretary of the Lan-Oak Park District is hereby directed to file a certified copy of this Ordinance with the County Clerk of Cook County, within the time specified by law and said County Clerk shall extend the tax to produce the amounts levied herein upon the books of the Collector of the State and County taxes within said district, all as provided by law.

Section 5: This Ordinance shall be in full force and effect from and after its adoption as required by law.



**AN ORDINANCE DIRECTING THE COOK COUNTY CLERK TO REDUCE THE LAN- OAK PARK DISTRICT'S REAL ESTATE TAX LEVY YEAR 2023 LAN-OAK PARK DISTRICT, COOK COUNTY, ILLINOIS**

WHEREAS, there has been enacted, the Property Tax Extension Limitation Act 35 ILCS 200/18-185 et seq. (the "Act"), which will affect the amount of taxes extended for the District by the Cook County Clerk (the "Clerk"); and

WHEREAS, because the amount of the Equalized Assessed Valuation ("EAV") for property located in the District for 2023 was not known at the time that the District passed its Tax Levy Ordinance for 2023, it could not be determined whether the application of the provisions of the Act would affect the District's levy; and

WHEREAS, it is possible that when the EAV for 2023 is established in 2024, the limiting rates set forth in the Act will require the Clerk to reduce the District's levy; and

WHEREAS, unless directed otherwise by the District, the Clerk has indicated that the District's levy will be reduced proportionately over all funds, if necessary; and

WHEREAS, the Clerk has requested direction from the District at the time of the filing of the Tax Levy Ordinance for 2023, as to which funds should be reduced, and by what amounts, if it becomes necessary; and

WHEREAS, the District prefers to give such direction.

NOW, THEREFORE, be it and it is hereby ordained by the Board of Park Commissioners of the LAN-OAK PARK DISTRICT, Cook County, Illinois, as follows:

Section 1. The Cook County Clerk is hereby directed to reduce the District's fund levies as follows, only if necessary due to the application of the Act:
