Senior Superintendent of Strategy & Operations – Report: Desjardins explained that the Bock Park project will now be handles primarily by the Superintendent of Parks for the construction phase, spoke briefly about the 2025-2026 budget process, reported that a recreation supervisor is open and applications are being received, discussed if alteration is required for the refund policy, if a different process is required for citizen comments or complaints, reported the cost of having legal counsel attending meetings, the status of the district's special recreation membership, and the twice per week LARC visits organized and provided by Sertoma Star. Updates were provided for recreation enrollment, the upcoming summer program brochure, upcoming special events, the acquisition of a new dance teacher, addition of an adult trip, the cancellation of the July 3 fireworks, the addition of a July 3 movie event, and the possibility of skateboard classes.

Superintendent of Parks and Maintenance – Havran reported that HVAC Requests for Proposal forms have been distributed and are due back by March 24, the Bike Share bikes will be put out earlier than expected, the brush removal on the bike path, the lack of response from the village regarding a new business and their possible parking encroachment at the Park Plaza, there has been no response from the Rotarian from Rotary Park, the intention to improve the baseball/softball fields this spring, the progress on the nature center, preferred projects for the 2025-2026 year, the availability of applications for seasonal maintenance positions. Fitness and aquatic program enrollments and current fitness membership numbers were provided. The desired size for a new Oakley shelter was discussed.
